



In response to the Novel Coronavirus related prevention measures, all overseas students please follow the principles of Health and Epidemic Prevention

1. Students from China, Hong Kong and Macau and those who have transited through China, Hong Kong and Macau must abide by home quarantine, whether or not they are residential students, as soon as you enter Taiwan, please inform OICA office and move to the school's dormitory isolation floor for 14 days of quarantine.
2. Regardless of nationality students, students with a history of tourism are required to comply with independent health management for 14 days. Only 14 days after independent health management, you can enter the campus. If students are a resident of dormitory, please inform OICA office and move to the school's dormitory isolation floor for 14 days of quarantine.
3. Regardless of nationality students, if they are subjects to home quarantine or home quarantine for inspection, regardless of whether they are residential students, they will be moved to the school's dormitory isolation floor for centralized management.
4. Departments and units which are related of overseas students are requested to assist in all academic and school affairs matters for overseas students who fail to enter the campus due to health management. Such as: registration (payment of tuition fees, application for residence permit, application for health insurance, application for work permit), matters related to course selection. For ensure the right of education of overseas students.
5. 1082 semester transnational exchange activities will be suspended. Exchange students who have not yet entered Taiwan as of today (2020/02/21) suggest to suspend the exchange program. All exchange program students who in the light of the original plan should follow the school's overseas quarantine management methods.
6. Students who have not entered after 2020/3/2 will abide by the school's epidemic prevention principles. Degree students can apply for Study at Ease Project for COVID-19 Prevention in their country.
7. Please abide by the relevant regulations on central epidemic prevention. If you have concealed immigration information according to Article 62 of the Law on Prevention and Control of Infectious Diseases, those who do not follow the instructions of the competent authorities at all levels will be contaminated and sentenced to imprisonment of less than three years, detention or a fine of less than NT \$ 500,000.

Regulations for staying in isolation management floor:

1. The cost of living in the isolated floor of the dormitory is NT \$ 5,000.
2. All meals are ordered uniformly. Please pay NT \$ 4,000 for meals when you check - in. After 14 days, you will be refunded and replenished. You will not be allowed to go to other floors or go out during the 14-day staying on the isolated floor.
3. Students will receive a temperature record card when check-in and also will be invited to join the Line group. Please take your own body temperature every morning and evening and then take a picture after recording on the temperature record card and upload it to Line group. The record card is returned to the counter after the control period ends.
